ORIGINAL CERTIFICATES OF UPKJ REGISTRATION, MCMC NETWORK FACILITY PROVIDER (NFP) AND MCMC NETWORK SERVICE PROVIDER (NSP) LICENSES with the minimum validity period of Two (2) years shall be produced before the Tender Documents can be issued to qualified Contractors.

SARAWAK MULTIMEDIA AUTHORITY shall not be bound to accept the lowest or any bid submitted, nor to provide reason or compensation in anyway whatsoever to any Tenderer whose Tender has not been accepted.
- 9. SARAWAK MULTIMEDIA AUTHORITY reserves the rights to reject a tender that in the judgment of SARAWAK MULTIMEDIA AUTHORITY appear as each or combination of all of the following:
 - i. A Tenderer is unable to provide a satisfactory explanation for tendered rates and/or tender price;
 - ii. Tender price that are unrealistic; and
 - iii. Presence of arithmetical errors including those related to price and timelines. The tender submitted by a Tenderer who has not conformed to these terms may not be considered.
